- 8. The DPR cost should not exceed Rs.1000.00 lacs against which the Tribal Affair Department will provide 700.00 lacs and 300.00lacs are to be provided under convergence at District Level.**
- 9. The work should be executed strictly as per approved type Design and DPRs.**
